We also offer counseling for family members, close supporters and professionals.

Unfortunately, our facilities are not handicapped accessible. Please call us, so we can arrange a suitable place where the counseling can be held.

We will make every effort to find an interpreter if you don't understand German or are deaf.

## Violence has many faces.

Throughout the world women and girls are being discriminated against, threatened, abused, beaten and raped.

Women fall victim to violence during the day and at night, at home and in public, at the workplace and in school, both inside and outside the family, as well as in the media and advertising.

Violence against women and girls is against the law, and it doesn't matter if the perpetrator is the husband, the father, a friend or a stranger.

We will provide you with information, support and encouragement. No woman has to accept or endure abuse.

Women's Crisis Line is a counseling center for women and girls from every cultural, ethnic and social background, and regardless of residency status, age, disability and way of life.

We support women following an attempted or completed rape, sexual abuse, cyberbullying, domestic violence, physical, verbal or written threats, telephone terror, stalking, bodily injury up to and including attempted murder, sex and human trafficking, racist discrimination, and drug-facilitated assault (date rape).

### Intervention center

The intervention center is a haven and resource that the authorities and institutions, family members and trusted friends, and both the abused and the abuser can turn to for help.

Here you'll be given information about domestic and/or sexual violence and stalking. You will also be referred to other professional services as needed. Victimized women and their children will receive support from the Women's Crisis Line's counseling center.

The intervention center works proactively. After the police are called to the scene or charges are filed, the police will obtain the consent of the victims or affected persons and give their contact information to the intervention center. One of our female staff members then contacts the affected woman and offers her an opportunity to talk as soon as possible.
